

Illustrative Outline LPSA [Regional / Thematic] Working Group Work plan 2023-24

This illustrative outline for an annual working group work plan was prepared for the convenience of LPSA's Regional and Thematic Working Groups. There is no requirement for LPSA Working Groups to have a formal work plan. However, a write-up (whether informal or more formal, at the working group's discretion) of the working group's objectives, priorities, key stakeholders, and planned activities may be helpful to achieve greater internal unity of purpose among the working group's co-chairs, core working group members, LPSA member and external audiences (the global or regional community of practice). As such, the outline is purely suggestive.

1. Background

The Local Public Sector Alliance (LPSA) seeks to promote inclusive, equitable societies and sustainable global development by enhancing the understanding of decentralization and localization as complex, cross-cutting and multi-stakeholder reforms.

LPSA aims to elevate the global debate on public sector decentralization and localization, by (1) advancing the state of knowledge on decentralization and localization; (2) ensuring a more informed and interconnected global Community of Practice, where knowledge sharing takes place across countries, disciplines, institutions and sectors; and (3) engaging in convening, outreach and field building to achieve a larger, more empowered global Community of Practice, with country-level champions well-positioned to champion decentralization and localization reforms.

As a global professional network, LPSA recognizes the cross-cutting, multi-disciplinary and multistakeholder nature of the global Community of Practice working on different aspects of decentralization and localization. Inspired by the diversity and depth of experience and expertise of LPSA's membership, the Alliance has established a number of regional and thematic working groups to address different aspects of decentralization and localization. This includes the LPSA [name] Working Group.
