The Local Public Sector Alliance is a non-profit organization established to promote inclusive, equitable societies and sustainable global development by enhancing the understanding of decentralization and localization as complex, cross-cutting and multi-stakeholder reforms.

Convening, outreach, and field-building LPSA engages in activities designed to bring global stakeholders together around the topics of decentralization, localization, and multilevel governance, including outreach to researchers, practitioners, policymakers, and development partners, as well as support to its regional and thematic Working Groups. By the end of 2025, LPSA had grown into a global Community of Practice with 2,443 members and subscribers across government, academia, civil society, and international organizations. In 2025, LPSA convened 9 Regional Working Group meetings and 6 Thematic Working Group meetings, with 539 members participating in working group activities. It also supported extensive convening and outreach through its intervention on Localizing Women's Economic Empowerment and Childcare in Africa. Through its convening and field-building role, LPSA strengthens coalitions, supports peer exchange, and advances a more coherent and influential global field focused on effective multilevel governance systems.

4b (Code:) (Expenses \$ 74,804 including grants of \$ 79,428) (Revenue \$)

Knowledge Sharing LPSA engages in the sharing of knowledge and information related to decentralization, localization, and multilevel governance through its website (Decentralization.Net), electronic newsletters, webinars, meetings, online learning activities, and digital collaboration platforms. In 2025, Decentralization.Net recorded over 68,000 sessions, over 50,000 users, and in excess of 88,000 page views. LPSA also launched the LPSA Member Portal (localpublicsector.org), a free digital hub connecting practitioners, researchers, and policymakers through discussion forums, working groups, directories, and training resources. In 2025, LPSA provided in-person and virtual capacity development and knowledge development activities in Africa and the MENA region. Since 2021, LPSA webinars and meetings have engaged thousands of researchers, practitioners, and policymakers worldwide. Through these activities, LPSA strengthens the capabilities of reform actors and supports more informed, coordinated, and adaptive approaches to multilevel governance reform.

Knowledge Development LPSA engages in the development of general and specialized knowledge products related to decentralization, localization, and multilevel governance, including primers, diagnostic methodologies, comparative assessments, and analytical frameworks. During 2025, LPSA further advanced and disseminated a suite of flagship knowledge products, including its Decentralization and Fiscal Decentralization Primers; the Decentralization and Multilevel Governance Glossary; the Local Governance Institutions Comparative Assessment (LoGICA) Framework; the Intergovernmental Fiscal and Expenditure Review (InFER) Framework; the Multilevel Governance as an Opportunity or Obstacle to Development (MOOD) Assessment; and the PROMOTE framework for results-oriented local governance. LPSA also expanded its comparative Intergovernmental Profiles and laid the foundations for a Multilevel Governance Databook. LPSA knowledge products were downloaded thousands of times during the year, contributing to stronger evidence, better policy framing, and more informed reform processes related to multilevel governance worldwide.
